

TERMS AND CONDITIONS FOR “KIDS CLUB LIGHTNING PLANET COMPETITION 2024”

Information on how to enter and prizes form part of these Terms and Conditions. Participation in this “**KIDS CLUB LIGHTNING PLANET COMPETITION 2024**” Promotion (“**Promotion**”) is deemed acceptance of these Terms and Conditions. All times stipulated in these Terms and Conditions are based on VIC local time.

ELIGIBILITY

1. Subject to condition 4, this Promotion is only open to Australian residents **aged 18 years or over**.
2. The following are ineligible: (i) employees of the Promoter, the Scentre Group or any of the tenants or retailers in Westfield Southland Shopping Centre (“**Participating Centre**”) or any of the Promoter’s agencies that are associated with the Promotion; (ii) the spouse, defacto spouse, parent, child or sibling (whether natural or by adoption) of an excluded employee; and (iii) any person who the Promoter has previously notified is not permitted to enter the Promoter’s promotions.

PROMOTION PERIOD

3. This Promotion commences on **Wednesday 17 July** and ends at **1:00pm AEST/AEDST on Wednesday 18 September 2024**(“**Promotion Period**”).

HOW TO ENTER

 - Download the Westfield App and become a Westfield member. Make sure you have the most up to date version of the Westfield app.
 - In your Westfield Plus app select the ‘Kids Club Southland Lightning Planet competition. Follow the prompts at the bottom of your screen, entering your details.

GENERAL
