

TERMS AND CONDITIONS FOR “WESTFIELD INNALOO OLYMPIC GAMES QUIZ COMPETITION 2024” PROMOTION

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this Westfield Innaloo “**OLYMPIC GAMES QUIZ COMPETITION 2024**” Promotion (“**Promotion**”) is deemed acceptance of these Terms and Conditions. All times stipulated in these Terms and Conditions are based on WA local time.

ELIGIBILITY

2. Subject to condition **4** this Promotion is only open to Australian residents **aged 16 years or over**.
3. Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to these Terms and Conditions. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to the minor entering this Promotion.

WINNER NOTIFICATION

9. The provisional winner(s) will be notified in writing via email. A provisional winner will only be deemed a winner once verified by the Promoter.

UNCLAIMED PRIZE DRAW
